**ORDER-**

In the reference 1<sup>st</sup> read above, Government have issued orders relaxing ban on transfers from 25.04.2017 to 24.05.2017 and framed certain guidelines for effecting transfer of Government employees. In the reference 2<sup>nd</sup> read above, while communicating the G.O, certain instructions were issued to all the Government Degree Colleges in the State facilitating the employees to submit request transfer applications. In the reference 4<sup>th</sup> read above, Government have clarified that the employees who have completed 3 years of continuous service at a station but less than 5 years of service are eligible to apply for transfer only if they fulfill any of the five conditions laid down therein (such as medical and spousal grounds etc).

The video counselling was held on 22.05.2017 to consider and effect the transfers as per the options exercised by the employees. Accordingly, many of the employees are transferred to the places of their choice. However, some of the employees could not be accommodated at their place of choices as there are no vacancies and in such cases they are posted to the colleges where there are vacancies. Further, individuals who have completed more than 5 years of service at a station but have not exercised their option though online and are disturbed due to posting of another individual, are posted to needy Government Degree Colleges on administrative grounds.

In the light of the video counselling and on examination of all the cases with reference to G.O.1<sup>st</sup> and 4<sup>th</sup> read above, the transfers and postings are ordered in APCES as shown in the ANNEXURE - I with immediate effect.

The details of transfers considered at request or on spousal grounds or on administrative grounds are mentioned against their names respectively. The individuals who are transferred at request are not entitled for any T.T.A and joining time etc., as the postings are ordered at their request. The employees who are transferred on administrative grounds or posted to other than the place of their choices are eligible for T.T.A & joining time etc.

The Principals, Government Degree Colleges concerned are requested to relieve the individuals who are under orders of transfer at once without waiting for the substitute with instructions to report at his / her new station and report compliance.



NOW, THEREFORE THIS AGREEMENT WITNESS AS FOLLOWS:

1. That the party to the second part agrees to perform the teaching work in accordance with the curriculum of the University for the course from (date of permission) 01.06.2022 to 31.03.2023 or the last day of instruction of University concerned whichever is earlier and that the party to the second part shall carry out further instructions given to him by the College Planning and Development Council (CPDC) from time to time in the discharge of his/her duties as a teacher, mentioned in Para I above.
2. That the part to the second part agrees after being informed that he/she is fully aware of the fact that his/her service is being taken not to fill any vacancy either on temporary or permanent basis, that he/she will be paid a consolidated amount per month during the contract period and that his/her contract shall automatically come to an end on expiry of the said period or on report of a regular Lecturer to duty in that subject whichever is earlier. The contract shall not be treated as continuing from the past but as new contractual arrangement for limited duration.

That the party to the second part agrees after being informed that he/she is fully aware of the fact that his/her service is being taken not to fill any vacancy either on temporary or permanent basis, that he/she will be paid a consolidated amount per month during the contract period that his/her contract shall automatically come to an end on expiry of the said period or on report of a regular lecturer to duty in that subject whichever is earlier. The contract shall not be treated as continuing for the past but as a new contractual agreement for limited duration.
3. That the contract is terminable by the party of the first part i.e., college planning and development council at any time during the said period and the party of the second part in such case is entitled to only prorate amount till such time. In case of termination during the said period for any reasons, the party of the second part is not entitled to question the correctness of the decision of the college Planning and Development Council.
4. That the party of the second part is not entitled for any other perks allowances or any other facility except for the consolidated amount payable monthly mentioned in condition 3 above.
5. That if the party of the second part is not willing to continue as contract faculty, he/she should give a prior notice of one month to the party of the first part.



4. That the party to the second part shall work under the supervision of the Principal of the College.
5. That the work performance of the party of the second part will be assessed by the Head of the Department of the concerned subject/faculty as well as the Principal of the College.
6. That he/she is not entitled to any renewal or extension or continuation of the contract on any ground whatsoever.
7. That the service rendered during the contract will not be construed or reckoned as part of any regular appointment for any post in the Government and therefore no credit or weightage will be given for the service rendered in the contract period.
8. That if he/she registers less than 40% pass percentage in the subject(s) taught during the last year shall be terminated.
9. **Teacher Evaluation by the Students:** That the party to the first part shall take Students evaluation of the party to the second part in the prescribed format circulated to all the colleges in first quarter of the contract period and if performance of the contract faculty is not satisfactory he/she shall be terminated.
10. That any dispute arising out of this contract shall be subject to the jurisdiction of the competent court.
11. That the relationship between the two parties is purely contractual and strictly as per the terms mentioned above.





